The Mental Capacity Act 2005 Deprivation of Liberty Safeguards will be implemented from April 2009. From that date Registered Care Home Managers will have new statutory duties regarding residents who lack mental capacity and some residents will not be able to be admitted without prior authorisation from the Local Authority, **so it is essential that you are prepared !**

NTSG funding is enabling SCA in partnership with SCC to offer **Registered Care Home Managers** the opportunity to attend one of our funded workshops. **The workshop will provide important learning for all Care Homes but will be essential for those who provide care to people who may lack mental capacity to consent to their continuing admission to the home.** We are hosting the workshops in Surrey to promote awareness, discuss practice implications and ensure you have the necessary information. These will be the only free workshops that will be provided in Surrey before the new Safeguards are implemented. The Deprivation of Liberty Safeguards will form part of routine CSCI inspections from April 2009.
